# 4. What is included with the apartment?

All apartments are delivered with a stove, oven, extractor fan, and air conditioning units. We offer a furniture package at an additional cost, which will be sent to all owners once available.\*

#### 5. Maintenance Cost:

The HOA fee is approximately \$2.5 USD to \$3 USD per square meter.

## 6. How many parking spaces per apartment?

- One parking space per apartment.
- Visitor parking will be available.
